Latham, New York. This warranty shall be void unless the attached card or electronic registration has been completed and sent to Performance within 30 days of installation.

If this product should fail during the warranty period because of a problem covered by this warranty, the purchaser should review the reverse side of this warranty for instruction on the proper method of filing a claim for warranty coverage. The purchaser may be required to have the product inspected by an installer and/or provide photographic representation of the defective portion of the wall panel. Upon inspection of all related reports and/or photographs, the purchaser will be informed as soon as possible as to the disposition of the claim.
